The recipients of the 2026 Business Awards will be honored during the Chamber's Celebration of Business Leadership on June 18, 2026.

Award Nomination Criteria

- Award recipients are honored for their professional leadership/accomplishment and involvement in the local community. (see criteria below)
- Nominees must be employed by a Main Line Chamber of Commerce member in good standing.
- Chamber members and non-Chamber members may make nominations.
- While individuals and companies are encouraged to nominate others, self-nominating is also permitted. The content of the nomination, including any metrics, will be the key determinants – above and beyond consideration of the individual or company making the nomination. In all cases, nominations should strive to tell a fact-filled story of why an individual or company should be honored.
- Nominations should be submitted by email to kdilullo@mlcc.org Subject: Award Nominations.
The deadline for receipt of nominations is 5 pm on Monday, May 11, 2026.
- Nominations will be reviewed by a Judging Panel. All nominations are kept strictly confidential. Judges reserve the right to divide categories into subcategories based on the volume of submissions.

Nominations will be accepted for CFOs who have held their position as a staff member for a minimum of three years and demonstrate the following attributes:

- Financial success/growth,
- Commitment to good ethics and effecting reporting,
- Demonstrates discernment and a focus on continuous improvement,
- Devotes time and energy to improving the local community,
