Nominations may be made only by members in good standing of The Main Line Chamber of Commerce. Feel free to make nominations even if you cannot supply all of the details. You may nominate more than one person. Please make a copy of this form for each nominee.

The recipients of the 2026 Business Awards will be honored during the Chamber's Celebration of Business Leadership Luncheon on June 18, 2026.

Award Criteria

The F. Karl Schauffele Community Service Award is presented to the person whose efforts and good works have impacted the Main Line or areas around the Main Line in meaningful and significant ways. The award is intended to honor someone whose attributes emulate those of the late F. Karl Schauffele, past President of The Main Line Chamber of Commerce, in whose name this award is made.

Candidates:

- First and foremost, candidates should emulate Karl and the manner in which he conducted himself as a person and as President of The Main Line Chamber of Commerce. Words such as selflessness, courage, integrity, and kindness describe some of the appropriate attributes.
- The award shall be presented to an individual. Although it may be made posthumously, a living recipient is preferable.
- Nominees will be individuals, and not groups or corporations, although it is possible that a group or corporation might qualify under extraordinary circumstances.
- A geographic presence on the Main Line is preferable, but not a prerequisite. However, the recipient must be tied to the Main Line in some fashion.

Process:

- The award will be made annually at the Main Line Chamber's Annual Celebration of Business Leadership luncheon (June 18, 2026).
- Nominations may only be made by or through a member in good standing of The Main Line Chamber of Commerce.
- Nominations will be reviewed by a panel of judges and the winner will be notified by the President of The Main Line Chamber.
