The Green Business Award will honor the achievement of a Main Line Chamber of Commerce member who is leading the way in the green sector. Nominate yourself or a business you know for the 2026 Green Business Award from The Main Line Chamber of Commerce!

The recipients of the 2026 Business Awards will be honored during the Chamber's Celebration of Business Leadership on June 18, 2026.

Award Nomination Criteria

- Award recipients are honored for their professional accomplishments and involvement in the local green community. (see criteria below)
- Nominees must be Main Line Chamber of Commerce members in good standing.
- Chamber members and non-Chamber members may make nominations.
- While individuals and companies are encouraged to nominate others, self-nominating is also permitted. The content of the nomination, including any metrics, will be the key determinants – above and beyond consideration of the individual or company making the nomination. In all cases, nominations should strive to tell a fact-filled story of why an individual or company should be honored.
- Nominations should be submitted by email to kdilullo@mlcc.org Subject: Award Nomination.
The deadline for receipt of nominations is 5 pm on Monday, May 11, 2026.
- Nominations will be reviewed by a Judging Panel. All nominations are kept strictly confidential. Judges reserve the right to divide categories into subcategories based on the volume of submissions.

If you know of a business that has been in existence for at least five consecutive years with any combination of these attributes:

- Extraordinary performance related to sustainable environmental practices,
- Commitment to environmentally friendly practices, both within their physical office space and within the community,
- An openness to innovation in the green community and within their specific industry,
- Devotes time and energy to improving the quality of life on the Main Line,
- Received local, state, professional, trade or other recognition,
- Active in green professional, business, or trade associations/groups.
